Seismic Digital Shift gamification official rules

The Seismic Digital Shift Contest ("Contest") is sponsored and administered by Seismic Software Inc. (on behalf of itself and its affiliate entities ("Seismic"). By participating in the Contest, each Participant (defined below) agrees to abide by these Official Rules, including all eligibility requirements, and understands that the results of the Contest, as determined by Seismic and its agents, are final in all respects. The Contest is subject to all federal, state and local law and regulations, and is void where prohibited by law. The Contest is in no way sponsored, endorsed or administered by, or associated with any entity other than Seismic. NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility

The Contest is open only to "Participants" who at the time of entry are:

- (c) have a valid event registration

Points are tallied on the participants behalf by a widget that is unique to each participant when they access the event. The participant will be able to see their points accumulation in real time.
